By Law Change

Dear Club Members:

At the April 2011 meeting a proposal will be made to the general membership to amend one of our bylaws. This is Section 6, Membership Balloting and Candidate Approval. A proposal will be made the eliminate voting new members into the club. A current club member will have to sponsor a new candidate. If there are any problems or complaints by club members the sponsor will be charged with taking care of that situation. In the past there were members voted in who the membership were not happy with, so voting someone in does not guarantee anything.

The old bylaw is as follows: "Membership Balloting and Candidate Approval. When a new member is proposed, there will be a secret ballot submitted by all members present. When a candidate is sponsored, written notification will be made to the General Membership advising of the date, time and place the General Membership Ballot will take place. Such notification will be sent not less than seven (7) days prior to the scheduled vote. Membership Approval is contingent upon the sponsored candidate receiving no more than one negative vote. No member may abstain. Upon completion of a "witnessed vote count," the Membership Committee Chairperson or the President will only specify whether or not the vote was favorable or negative. All ballot totals will remain anonymous. In the event that two negative notes are witnessed, ballot counting shall shop immediately. The candidate shall be notified by the president or membership committee chairman of the results by letter or by electronic mail."

The new bylaw reads as follows (unless modified by members): "When a new member is proposed by a member sponsor, the member sponsor shall invite the candidate to a club meeting so that the candidate can see what the club is about and can make an informed decision whether they want to join the club. After bringing the candidate to a meeting the sponsor shall present the potential member with an application to be filled out by the candidate. At that point the sponsor will submit the application to the Board or the Membership Committee Chairman for examination and then will notify the sponsor whether or not member seems right for the club. If approved the candidate will come to the next meeting, pay their dues if not already paid, and become a member of the club"

This second bylaw is subject to modification by the membership at the April meeting. There will be a vote on the new bylaw at the May meeting. If anyone has any questions or comments you can reach me at jpunge@optonline.net.


My son & I off Singer Island Florida 3 weeks ago. Fishing down there is just unbelievable.

Any school child knows, or at least believes, that if you see a person or boat in distress on the water, the "law of the sea" demands that you render assistance. Simple human decency would require no less and, from time immemorial, this has been law of the sea. But we live in a modern and litigious world... Having just come in from patrol where USCGAux 251384 provided assistance to a disabled and adrift vessel, it occurred to me that we ought to refresh this information (see SSP, "The Good Samaritan – Safety of Life at Sea", 8/15/07.) So, what are the facts?

Your Duty to Assist

As said above, from time immemorial, seamen have always come to the rescue of those in distress on the high seas. In fact, Admiralty Law has consistently encouraged such actions. Those "that go down to the sea in ships" have by law and precedent been urged to assist in life-saving efforts. On the US Federal books (46 U.S.C. paragraph 2304), it states:

"A Master or individual in charge of a vessel <u>shall</u> render assistance to any individual found <u>at sea</u> in danger of being lost, so far as the Master or individual in charge can do so without serious danger to the Master's or individual's vessel or individuals on board." (Emphases mine.)

It goes on to specify that those that fail to do so can be fined (up to \$1,000) and imprisoned (up to 2 years). When a maritime law says, "shall", it means **must**.

For those that are expert wordsmiths, the term "at sea" doesn't evoke the Forge River or Seatuck Cove – or does it? Centuries of practice would argue that they are part of the seas and, in fact, the USCG Rules of Navigation (the COLREGs) embody, in Rule 1, the connectedness of our waters:

"These Rules shall apply to all vessels upon the high seas and in all waters connected therewith navigable by seagoing vessels."

The "Good Sam" Laws


The Congress and Admiralty Courts have addressed this little "at sea" loophole via the Good Samaritan regulations. Federal Law 46 U.S.C. paragraph 2303(c) states that the Master or individual involved in rendering assistance "is not liable for damages as a result of rendering assistance or for an act or omission in providing or arranging salvage, towage, medical treatment or other assistance when the individual acts as an ordinary, reasonable and prudent individual would have acted under the circumstances." This creates, in legalese, a "high legal hurdle" to prove a case against a Good Samaritan. The Admiralty Courts have always considered the chilling effect that a decision against a Good Samaritan would have upon centuries of life-saving practice. Even if the Good Samaritan made the situation worse, the Court has only ruled against the "Good Sam" if they were grossly negligent or exhibited "reckless or wanton conduct" in attempting the rescue.

This doesn't mean that the rescuer even has to succeed – not all rescues do. The Court recognizes that, "under the bright light cast by hindsight", a rescuer might have done something differently and thus outcomes might have been different. "A rescue attempt must be considered in the light of the circumstances that faced the rescuers when they acted and not with the wisdom of an 'armchair admiral' after the fact." (Korpi v the United States, 961 F. Supp. 1335)

The tough part for you - the skipper - is deciding whether he or she is "standing into danger" that is beyond the

capabilities of the crew or the vessel. However, when you see some vessel alongside the rocks in the Moriches Inlet, most skippers will try – and the Courts will applaud you, even if you have to back away.

Let me also add this – call the US Coast Guard on channel 16 as soon as you see the situation develop. They will give you advice and counsel as the facts you relay would imply – and get a boat of helicopter underway at the same time. Also, all the commercial salvors, as is required ANY boat equipped with a VHS radio is required to do by Federal regulation, monitor channel 16 (see SSP, "Your Radio – Sounding Smart", 8/01/07.) They themselves are accomplished skippers and may also find the opportunity to assist in the circumstances






Worlds Cheapest, Dumbest Fly I Ever Used: but also one of the most effective flies that I have in my fly box. Either way this fly is a producer. Several years ago I was sitting in a audience waiting for the Club to disposed of their business before making a presentation to the members. Sitting there I could not help overhearing a conversation taking place behind me. This member describing how he took fish after fish on his favorite fly one evening on the Carmins River. Listing intently to the conversation he mentioned the name Saran Fly of which I tried to think if I ever heard of this pattern. I kind of prided myself on the knowledge of various patterns and my memory was still pretty good but the name did not ring a bell. Curious I introduced my self and asked again what the name of the fly was thinking perhaps that I made a mistake. As we engaged in conversation I learned a little more and was quite sur-




prised that the main ingredient of the fly was ordinary kitchen brand Saran Wrap! After a little prodding he went out to his truck to get a sample to show me. I just could not believe that Saran Wrap could make an effective fly. I later found out that it is a real fish getter in fresh water.



HOOK 3906 - 3906B (Mustad or equivalent)

SIZE 16 - 24
BODY Saran Wrap
TAIL None
WING None
THORAX Dk Dubbing
THREAD Clear Mono

Cut a triangle piece of Saran wrap or plastic bag about 3/16" at the widest point about 2" long. Tie onto hook then into a dubbing loop and twist. Wrap around hook shank until just short of the head. Add some dark dubbing and your done.



Tie it onto your Dry Fly or Nymph pattern with an improved clinch knot I use about 1 foot of 5X tippet and your good to go. I fish it under a Dry Fly or Nymph pattern with an indicator with great results. My preference for a great setup for searching new waters.



ROD REVIEW

Cortland Big Sky 912-4 12wt 4pc 5 1/2 oz

Had a chance to try one out a week or two back and needles to say I was quite impressed. Met up with Enrico Puglisi who was telling me about his favorite Tarpon Rod and gave me the opportunity to try it out. Needless to say I was taken back by it's performance. Very easy to cast actually feels like a 9 weight. But it is a legitimate 12 weight. He had a Monic Clear Tarpon Line which has a very hard finish and it went through the guides with ease. Have been looking for a 12 weight and this may be my next purchase. At a advertised cost on the internet of \$ 239.00 it is quite a bargain complete with rod tube.
